PHOTO CONTEST RULES, TERMS AND CONDITIONS:

1. The 2008 photography contest is open to Canadian Residents only. - **If you are under 18 years old please read below** -
 - a. *Entrants who are under the age of 18 at the date of entry are eligible to enter and win a prize provided his or her parent or legal guardian accepts any such prize and the terms and conditions hereof for and on behalf of such entrant.*
2. The contest will run between February 18th, 2008 and May 15th, 2008. **All photographs, entry forms and releases must be postmarked by May 15th, 2008. *Late entries will be disqualified. *Images submitted after the close of this contest will still be considered for use by the Town of Grande Cache and its affiliates. Appropriate signed releases and acknowledgements must still accompany any future submission.***
3. A completed contest entry form must accompany each photograph. Entries must be signed and dated. Only entry forms with complete, accurate and legible information will be considered eligible. Photographers may enter more than one image as long as each is accompanied by a new entry form.
4. **Photographs must be taken in the Grande Cache region.**
5. Photographs must be previously unpublished. Photographs that have been published in any form prior to entry into the contest will be disqualified.
6. All photographs and prints must be in sharp focus. Prints must be at least 5" by 7" (inches) or larger and be printed at a professional level of quality on **photographic paper**. Images printed on ink jet paper will not be accepted. ***No email submissions are accepted as all forms and documents submitted must be signed originals.***
7. All **digital images** must be accompanied with a high resolution print on **photographic paper** that is at least 5" by 7" (inches) large **and a CD** with the high-resolution digital file sized at a minimum of 5" by 7" (inches) at 300 dpi. Only one image per CD. **Digital manipulations will be disqualified.** Images printed on ink jet paper will not be accepted. ***No email submissions are accepted as all forms and documents submitted must be signed originals.***
8. Damaged photographs will not be accepted. Prints cannot be stapled, taped, or folded and neither the back nor the front of the photograph should be written upon. Camera-imprinted data is acceptable as long as the integrity of the photograph is not altered and the data doesn't obstruct the focal point of the image. **Any violation of this provision will result in disqualification of the entry.**
9. Information identifying the photograph should be placed on the entry form and should note the location, event and other pertinent information.
10. Each photograph that includes **identifiable subjects** (people, etc...) must be accompanied by a **separate, signed release** from identifiable subject in the photograph. Releases that cannot be verified for authenticity by the Town of Grande Cache, for any reason (including missing, incorrect or incomplete contact information on the release form) will result in the disqualification of the entry.
11. The Town of Grande Cache or their agents or assigns are not responsible for late, lost, damaged, destroyed or misdirected entries, or for miscommunications, misdirected transmissions, or other errors of any kind whether human, mechanical or electronic.
12. All entries become the exclusive property of the Town of Grande Cache and **will not be returned** to the photographer. The Town of Grande Cache reserves the right to use the photographs in printed materials promoting the Town of Grande Cache and area without paying compensation to the photographer or the subjects.
13. Prizes will be awarded only to entries that the contest judges deem worthy. Some prizes may not be awarded if no acceptable entries are received. All decisions by the judges are final.
14. Winners will be notified prior to posting on the Town of Grande Cache's website, www.grandecache.ca
15. This contest is void wherever restricted or prohibited by federal, provincial or municipal laws.
16. **Employees of the Town of Grande Cache and agencies employed by the Town of Grande Cache are prohibited from winning this contest. Image submissions are still accepted for publication purposes according to contest rules.**
17. Contest entrants agree to abide by the terms of these Official Rules and by the decisions of the judging committee, which are final on all matters pertaining to contests. The return of any prize/prize notification as undeliverable may result in disqualification and selection of an alternate winner.
